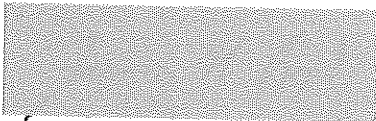

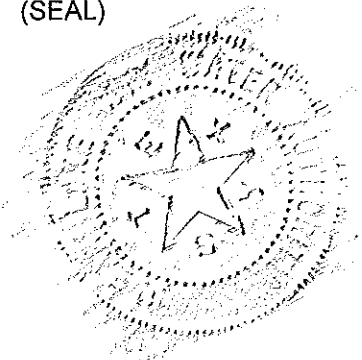
1. Consider and act upon renewal of the CLCWA Employee Health Insurance Plan;

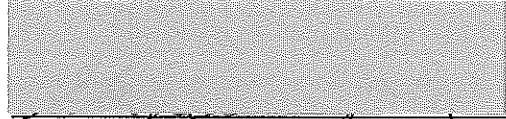

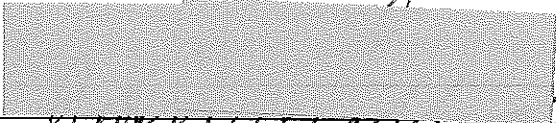
- Special Meeting The Board of Directors of the Clear Lake City Water Authority convened in special session open to the public at the regular meeting place in its office at 7:45 p.m. on April 28, 2015. Roll was called of the members:

Mr. John Branch, Vice President;
Mr. Robert T. Savely, Secretary;
Mr. Gordon Johnson, Director;
Mr. W. Thomas Morrow, Director.
- All were present except Director Morrow.
- Also present were:

Mr. Curtis Rodgers, Director of Utilities;
Mr. William Schweinle, Attorney;
Mr. James Byrd, General Manager;
Ms. Alice Cumming, Tax Collector and Recording Secretary.

1. CLCWA Employee Insurance Renewal Approved Mr. Andy Bell with GBS, Inc., presented multiple options for the CLCWA's Employee Insurance for the Board to review and consider. The Blue Cross Blue Shield Plan RM-02 and an alternative plan was discussed at length. (A copy of which is on file in the official records of the District and identified as Exhibit B.)
- Thereupon, by motion duly made by Director Savely and seconded by Director Branch, the Board voted unanimously to approve the proposed (RM-02) Insurance Renewal for the employees and an additional \$10.00 increase per pay period for the employees contribution amount.
2. Abandonment of Drainage Easement A Release and Termination of Easement was presented to the Board for their review.
- After a discussion, Director Branch requested an executive session.
3. Special Meeting Adjourned and Reconvened in Executive Session At 8:40 p.m., President Yoder closed the special meeting and the Board reconvened in executive session to confer with its counsel.
4. Reconvene in Open Session The Board reconvened in open session at 9:15 p.m.
5. Abandonment of Drainage Easement Thereupon, by motion duly made by Director Johnson and seconded by Director Branch, the Board voted unanimously to table action on the Release and Termination of Easement.
