

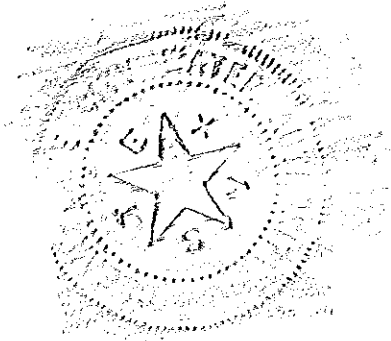

1. Public Hearing  
John B. Niday, Jr.

President Yoder announced the public hearing for Dis-Annexation, filed by John B. Niday, Jr., President of J Barron, LLC, of property identified in Petition as Lot 2, Block 1 of the Allen Center at Fairmont, and located at 6777 Fairmont Parkway, Pasadena, Texas 77505.

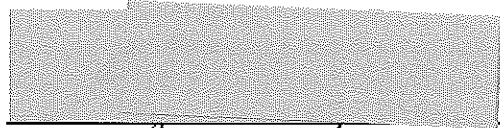
After the announcement of the public hearing, President Yoder turned conducting of the hearing over to Mr. Schweinle, attorney for Clear Lake City Water Authority (CLCWA). The entirety of the hearing was recorded, beginning with the announcement by the President. A number of stipulations of the parties were entered in the record. The witnesses were placed under oath. Thereafter, upon completion of the questioning of the witnesses called by each side, and cross examination of the witnesses, as well as questions from the Board Members, both parties rested their cases. It was then stipulated by the parties that the matter would be taken under advisement by CLCWA pending the finding and ruling of the TCEQ mandated by the Water Code. It was then further stipulated that upon receipt of the TCEQ ruling by CLCWA and review of the entire record, CLCWA would, at a regularly scheduled meeting with appropriate agenda notice, hear further argument on legal and fact issues and thereafter announce its rulings. The recording of the hearing is on file in the official records of the District and is available for review upon request pursuant to the Public Information Act. (A copy of the agreed stipulations is on file in the official records of the District and identified as Exhibit B.)

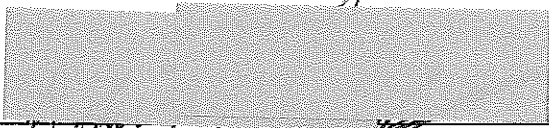
There was no action taken by the Board.
