1. Exclusion Contract with HC WCID #161  
Approved

By motion duly made by Director Branch and seconded by Director Morrow, the Board voted unanimously to approve the HC WCID #161 Exclusion Contract.

2. Service Agreement with HC WCID #161

3. Order Excluding HC WCID #161 from the Authority and Creation of a Sub-District

4. Notice to Purchasers (reflecting exclusion)

An amended Notice to Purchasers reflecting the HC WCID #161 exclusion was presented to the Board for review and approval. (A copy of which is on file in the official records of the District and identified as Exhibit E.)

By motion duly made by Director Savely and seconded by Director Johnson, the Board voted unanimously to approve the amended Notice to Purchasers.
