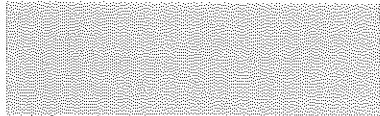
To: All Persons Interested in the Meeting of the Clear Lake City Water Authority Board of Directors:
